

 - No quotations will be considered from persons in the services of any organ of the state
 - Service providers to complete in fully all relevant MBD's (1,4,6.1,8,9) that are available on municipal website
 - A certified copy of the most recent municipal account in which the business is registered. District municipality (water) and Local municipality (rates, electricity and other) or if the bidder is a tenant then a letter or certificate from landlord indicating that the levies are not in arrears or an affidavit stating that the ward in which business is registered is exempted from paying rates, electricity and water.
