Only Bidders who are registered with CIDB in a contractor grading of **6CE** or higher will be eligible to Bid for these Bids. In case of Partnership /Joint Venture a consolidated CIDB Registration Certificate meeting these requirements must be attached. Bidders must have proof of CIDB Registration by the closing date failing which their Bid will be disqualified.

The physical address for collection of bid documents is Mandeni Municipality, Civic Centre, 2 Kingfisher Road, Mandeni (cashiers office) upon presentation of a receipt proving prior payment of a non-refundable fee of R500.00 (inclusive of VAT), (Cash or EFT: Ref no.: Bid No. and Bidder's Name). Bid documents will be available from 08h00 on Wednesday, 1 March 2023. The cut-off time for selling of bid documents is 15h00 on Tuesday, 14 March 2023.

A compulsory clarification meeting with representatives of the Employer will take place at the Sibusisiwe Hall, Mandeni on Wednesday, 15 March 2023, starting at 10h00 thereafter proceeding to the site. Failure to attend the compulsory clarification meeting with the bid document will disqualify the tender. The doors to the venue will be closed at 10h00 and no bidder will be permitted to enter afterwards. Bidders that do not bring the document to the briefing will be disqualified.



Bids shall be placed in sealed envelopes, endorsed "BID NO. AND BID DESCRIPTION' and be placed in the Tender Box situated at the reception: Civic Centre, 2 Kingfisher Road, Mandeni, not later than 12h00 (time will ONLY be determined by the Municipal clock at the reception) on Friday, 31 March 2023. Bids are to be submitted on the bid documentation provided by the Municipality. Late submission, electronic or faxed bids will not be accepted.

Only Bidders registered on Central Supplier Database (CSD) will be considered and must provide proof of registration.

The successful bidders will be required to subcontract 30% of the scope to a local contractor. The following PPPFA Regulations 2022 Specific Goals are applicable for 80/20 evaluation criteria:

The Mandeni Municipality subscribes to the preferential procurement policy framework Act, Act No. 5 of 2000 and associated Regulations of 2022. Bids will be evaluated and adjudicated in terms of the Mandeni Municipality's SCM Policy in two stages. First stage of evaluation is functionality and second stage being price (form of offer). Bids shall be valid for a period of 120 days. The Mandeni Municipality does not bind itself to accepting the lowest bid, either wholly or in part or give any reason for such action. All bidders must provide audited annual financial statements (AFS) for the past 3 years for companies required by law to be audited. For companies not required by law to be audited, AFS for the past three years or since the date of establishment if established during the past three years. All prospective bidders will be screened in accordance with the National Treasury's Defaulters Data Base. Canvassing in any form in the gift of Council is strictly prohibited and will lead to the disqualification of the bid.
