SUPPLY AND INSTALLATION OF NEW GRASS SODS AT KWANCEDOMHLOPHE STADIUM PITCH

The Mandeni Municipality invites bidders from suitably qualified and experienced contractors for the **RE-GRASSING OF KWANCEDOMHLOPHE STADIUM PITCH WITH NEW GRASS SODS**. Only Bidders who are registered with CIDB in a contractor grading of 2SH or higher will be eligible to Bid. In case of Partnership/Joint Venture a consolidated CIDB Registration Certificate meeting these requirements must be attached. Bidders must have proof of CIDB Registration by the closing date falling which their Bid will be disqualified.

The physical address for collection of bid documents is: Mandeni Municipality, Civic Centre, 2 Kingfisher Road, Mandeni (cashiers office) upon presentation of a receipt proving prior payment of a non-refundable fee of R500,00 (inclusive of VAT), (Cash or EFT: Ref no.: Bid No 19/22/23 Bidder's Name). Bid documents will be available from 8h30 on Wednesday, 19th April 2023. The cut-off time for selling of bid documents is 15h00 on Tuesday, 2nd May 2023.

A Compulsory clarification meeting with the representatives of the employer will take place at Sibuslwe Hall, Mandeni at 10h00, on Wednesday, 3rd May 2023. Bidders are urged to come with their purchased bid documents to the clarification meeting venue for signing. Failure to attend the compulsory clarification meeting will disqualify the tender. The doors to the venue will be closed at 10h00 and no bidder will be permitted to enter afterwards. Bidders that do not bring the document to the briefing will be disqualified.

Bids shall be placed in sealed envelopes, endorsed "**BID NO: 19/22/23 RE-GRASSING OF KWANCEDOMHLOPHE STADIUM PITCH WITH NEW GRASS SODS**" and be placed in the Bid Box situated at the reception: Civic Centre, 2 Kingfisher Road, Mandeni, not later than 12h00 (time will **ONLY** be determined by the Municipal clock at the reception) on Tuesday, 9th May 2023. Bids are to be submitted on the bid documentation provided by the Municipality. Late submission, electronic or faxed bids will not be accepted.

Only Bidders registered on Central Supplier Database (CSD) will be considered and must provide proof of registration. The following PPPFA Regulations 2022 Specific Goals are applicable for 80/20 evaluation criteria:
