 the bidder is a tenant, then a full lease agreement and a certificate from landlord
 indicating that the levies are not in arrears or a proof of residence and affidavit stating
 that the ward in which business is registered is exempted from paying rates, electricity
 and water. Failure to attach will lead to disqualification.
