Bid are to be completed in accordance with the conditions attached to the Bid document and must be sealed in an envelope and marked: "BID NO.: 45/22/23 SUPPLY AND DELIVER OF TRACTOR LOADER BACKHOE and must be deposited in the tender box situated at the reception: Civic Centre, 2 Kingfisher Road, Mandeni no later than 12H00, on Wednesday, 7th June 2023 at which time bids will be opened in public. Closing time will only be determined by the Municipal watch displayed on the Municipal wall at the reception. The name and address of the Bidder must be clearly written on the sealed envelope containing the Bid Document. Late submission, e-mail or fax bids will no circumstances be considered. Only bidders registered on Central Supply Database (CSD) will be considered.
