P415-459 WARD 3 STREETLIGHTS, IN THE MANDENI LOCAL MUNICIPALITY

Mandeni Municipality hereby invites bidders from suitably qualified and experienced contractors for the construction of a streetlighting in the Mandeni Local municipality. Only Bidders who are registered with CIDB in a contractor grading of **3 EP** or higher will be eligible to bid. In case of Partnership /Joint Venture a consolidated CIDB Registration Certificate meeting these requirements must be attached. Bidders must have proof of CIDB Registration by the closing date failing which their Bid will be disqualified.

The physical address for collection of bid documents is Mandeni Local Municipality, Civic Centre, 2 Kingfisher Road, Mandeni (cashiers office) upon presentation of a receipt proving prior payment of a non-refundable fee of **R600.00** (inclusive of VAT), (Cash or EFT: Ref no.: Bid

No 02/23/24 Bidder's Name). **Bid documents will be available from 08h00 on Thursday, 27 July 2023. The cut-off time for selling of bid documents is 15h30 on Tuesday, 8 August 2023.** Bidders are to ensure that the reference is as per instruction and no purchasing of multiple documents is allowed. There will be no selling of bid documents after 8 August 2023 at 15H30.

A compulsory clarification meeting with representatives of the Employer will take place at the **Mandeni Municipality Technical Services Boardroom, 2 Croton Place, Mandeni on Thursday, 10 August 2023, starting at 10h00** thereafter proceeding to the site. Failure to attend the compulsory clarification meeting with the bid document will disqualify the tender. The doors to the venue will be closed at 10h00 and no bidder will be permitted to enter afterwards. Bidders that do not bring the document to the briefing will be disqualified.

Bids shall be placed in sealed envelopes, endorsed "**BID NO: 02/23/24 P415-459 Ward 3 Streetlights, In The Mandeni Local Municipality**" and be placed in the Tender Box situated at the reception: Civic Centre, 2 Kingfisher Road, Mandeni, not later than **12H00 (time will ONLY be determined by the Municipal clock at the reception) on Wednesday, 16 August 2023.** Bids are to be submitted on the bid documentation provided by the Municipality. Late submission, electronic or faxed bids will not be accepted.

Only Bidders registered on Central Supplier Database (CSD) will be considered and must provide proof of registration.
