**PROCUREMENT OF A FULLY QUALIFIED AND COMPETENT ELECTRICAL CONTRACTOR TO MAINTAIN AND HANDOVER 31 TRANSFORMERS WITHIN WARD 3**

The Mandeni Municipality invites tenders for the **PROCUREMENT OF A FULLY QUALIFIED AND COMPETENT ELECTRICAL CONTRACTOR TO MAINTAIN AND HANDOVER 31 TRANSFORMERS WITHIN WARD 3**. It is estimated that Only Tenderers who are registered with CIDB in a contractor grading of 2EP or higher will be eligible to tender. In case of Partnership /Joint Venture consolidated CIDB Registration Certificate must be attached. Tenderers will have proof of CIDB Registration by the closing date failing which the tender will be disqualified.

The physical address for collection of bid documents is: Mandeni Municipality, Civic Centre, 2 Kingfisher Road, Mandeni (cashier's office) upon presentation of a receipt proving prior payment of a non-refundable fee of **R 600.00** (inclusive of VAT), (Cash, Debit Card or EFT: Ref no.: Bid No. Bidder's Name). **Bid documents will be available from Monday, 4 December 2023 until Wednesday, 13 December 2023 from 08:00 until 15h30."**

A compulsory clarification meeting with representatives of the Employer will take place at the **Municipal Council Chambers, 2 Kingfisher Road, Mandeni on Thursday, 14 December 2023**, starting at **12h00** thereafter proceeding to the site. Failure to attend compulsory clarification meeting with the bid document will disqualify the tender. The doors to the venue will be closed at **12h00** and no bidder will be permitted to enter afterwards. Bidders that do not bring the document to the briefing will be disqualified.

Tenders shall be placed in sealed envelopes, endorsed "**BID NO.: 10/23/24: PROCUREMENT OF A FULLY QUALIFIED AND COMPETENT ELECTRICAL CONTRACTOR TO MAINTAIN AND HANDOVER 31 TRANSFORMERS WITHIN WARD 3**" and be placed in the Tender Box situated at the reception: Civic Centre, 2 Kingfisher Road, Mandeni, **not later than 12h00, on Friday, 19 January 2024.**

Bids documents will not be opened in public however, the results will be published on the municipality's website. The name and address of the bidder must be clearly written on the sealed envelope containing the bid. **Late bids received by way of post, facsimile or e-mail will, under no circumstances, be considered.**

**Only Bidders registered on the Central Suppliers Database (CSD) will be considered and must provide proof of registration.** The Municipality reserves the right not to award bids to prospective suppliers who are not registered on the database. The following PPPFA Regulations 2022 Specific Goals are applicable for 80/20 evaluation criteria:
