The Mandeni Municipality invites tenders for the **Establishment of Panel of A**Maximum Of Three (3) Service Providers To Assist With Supply, Install,
Service And Repair Of Air conditioners For A Period Of 3 Years As And When
Required By Mandeni Municipality. It is estimated that Only Tenderers who are
registered with CIDB in a contractor grading of 1ME or 1EB or higher will be eligible to
tender. In case of Partnership /Joint Venture consolidated CIDB Registration Certificate
must be attached. Tenderers will have proof of CIDB Registration by the closing date
failing which the tender will be disqualified.

Closing time will only be determined by the Municipal watch displayed on the Municipal wall at the reception. The name and address of the Bidder must be clearly written on the sealed envelope containing the Bid Document. Late submission, e-mail or fax bids will no circumstances be considered. Only bidders registered on Central Supply Database (CSD) will be considered.

The Mandeni Municipality subscribes to the preferential procurement policy framework Act, Act No. 5 of 2000 and its associated Regulations of 2022. Bids will be evaluated and adjudicated in terms of the Mandeni Municipality's SCM Policy in two stages. First stage of evaluation is functionality and second stage being price and Specific Goals. Bids shall be valid for a period of 120 days. The Mandeni Municipality does not bind itself to accepting the lowest bid, either wholly or in part or give any reason for such action. All prospective bidders will be screened in accordance with the National Treasury's Defaulters Data Base. Canvassing in any form of gift to Council is strictly prohibited and will lead to the disqualification of the bid.
