Bidders are hereby invited from suitable qualified and experienced service providers for the **"ESTABLISHMENT OF A PANEL OF CONTRACTORS TO IMPLEMENT CIVIL AND OTHER GENERAL BUILDING INFRASTRUCTURE PROJECTS WITHIN MANDENI LOCAL MUNICIPALITY FOR A PERIOD OF 3 YEARS AS AND WHEN REQUIRED."**

Bidders should be registered with CIDB and have a CIDB grading of 2CE, 3CE, 4CE, 5CE and 6CE or Higher and 2GB, 3GB, 4GB, 5GB and 6GB or Higher. In case of Partnership /Joint Venture a consolidated CIDB Registration Certificate must be attached. Bidders must have proof of CIDB Registration by the closing date failing which their Bid will be disqualified.

The physical address for collection of bid documents is Mandeni Municipality, Civic Centre, 2 Kingfisher Road, Mandeni (cashiers office) upon presentation of a receipt proving prior payment of a non-refundable fee of **R600** (inclusive of VAT), (Debit Card, Cash or EFT: Ref no.: Bid No 21/23/24 Bidder's Name). Bid documents can also be emailed to bidders after submission of POP. The Municipal bank details may be requested via email from the Manager SCM. **Bid documents will be available from Wednesday, 24 April 2024 until Tuesday, 7th May 2024 from 08h00 until 15h30.** There will be no selling of bid documents after 7th May 2024 at 15H30.

A compulsory clarification meeting with representatives of the Employer will take place at the Tugela Community Hall, Mandeni on Wednesday, 8th May 2024, starting at 10h00. Failure to attend the compulsory clarification meeting with the bid document will disqualify the tender. The doors to the venue will be closed at 11h00 and no bidder will be permitted to enter afterwards. Bidders that do not bring the document to the briefing will be disqualified.
