**Manufacture, Supply and Deliver 60 x 6 cubic meters steel refuse skips to Mandeni Municipality.**

Suitably qualified bidders are hereby invited from suitable service providers for the Manufacture, Supply and Deliver 60 x 6 cubic meters steel refuse skips to Mandeni Municipality. It is estimated that Bidders who are registered with CIDB in a contractor grading of **3SL OR HIGHER** will be eligible to bid. In case of Partnership /Joint Venture a consolidated CIDB Registration Certificate must be attached. Bidders must have proof of CIDB Registration by the closing date failing which their Bid will be disqualified.

The physical address for collection of bid documents is Mandeni Municipality, Civic Centre, 2 Kingfisher Road, Mandeni (cashiers office) upon presentation of a receipt proving prior payment of a non-refundable fee of **R600.00** (inclusive of VAT), (Debit Card, Cash or EFT: Ref no.: Bid No 19/23/24 Bidder's Name). Bid documents can also be emailed to bidders after submission of POP. The Municipal bank details may be requested via email from the Manager SCM. Bid documents will be available from **Wednesday, 17 April 2024**. The cut-off time for selling of bid documents is **Wednesday, 24 April 2024**

Bids are to be completed in accordance with the conditions attached to the Bid document and must be sealed in an envelope and marked: **"BID NO.: 19/23/24 Manufacture, Supply and Deliver 60 x 6 cubic meters steel refuse skips to Mandeni Municipality.** and must be deposited in the tender box situated at the reception: Civic Centre, 2 Kingfisher Road, Mandeni **no later than 12H00, Thursday, 2 May 2024** at which time bids will be opened in public. Closing time will **only** be determined by the Municipal watch displayed on the Municipal wall at the reception. The name and address of the Bidder must be clearly written on the sealed envelope containing the Bid Document. **Late submission, e-mail or fax bids will no circumstances be considered. Only bidders registered on Central Supply Database (CSD) will be considered.**


