**SUPPLY AND INSTALLATION OF CONCRETE PALISADE FENCE WITH GATES AND
CONSTRUCTION OF A GUARDHOUSE AT HLOMENDLINI CEMETERY**

The Mandeni Municipality invites bidders from suitably qualified and experienced contractors for the Supply and Installation of Concrete Palisade Fence with Gates and Construction of a Guardhouse at Hlomendlini Cemetery. Only Bidders who are registered with CIDB in a contractor grading of 3SQ or higher will be eligible to Bid. In case of Partnership /Joint Venture a consolidated CIDB Registration Certificate meeting these requirements must be attached. Bidders must have proof of CIDB Registration by the closing date failing which their Bid will be disqualified.

Bid documents will be available from **Wednesday 19th of February 2025 to Tuesday, 4th of March 2025 during working hours Monday to Friday from 08h00 to 15h00**. A compulsory clarification meeting with representatives of the Employer will take place at the Tugela Community Hall, Mandeni on Wednesday, 5th March 2025 at 10h00 thereafter proceeding to the site. Failure to attend the compulsory clarification meeting with the bid document will disqualify the tender. The doors to the venue will be closed at **10h00** and no bidder will be permitted to enter afterwards. Bidders that do not bring the document to the briefing will be disqualified.

Bids shall be placed in sealed envelopes, endorsed "**BID NO.: 14/24/25 SUPPLY AND installation of GALVANIZED STEEL PALISADE WITH gates and construction of a guardhouse at HLOMENDLINI CEMETERY**" and be placed in the Bid Box situated at the reception: Civic Centre, 2 Kingfisher Road, Mandeni, not later than **12h00 (time will ONLY be determined by the Municipal clock at the reception) on Wednesday, 12th of March 2025**. Bids are to be submitted on the bid documentation provided by the Municipality. Late submission, electronic or faxed bids will not be accepted.
