The municipal bank details may be requested via email from the Manager. **Bid documents will be available from Friday, 25 July 2025 until Thursday, 07 August 2025 from 08h00 until 15h30.**

Bids are to be completed in accordance with the conditions attached to the Bid document and must be sealed in an envelope and marked: "BID no: 01/25/26 Panel of Attorneys for the Municipality for 3 Years/ 36 Months" and must be deposited in the tender box situated at the reception: Civic Centre, 2 Kingfisher Road, Mandeni no later than 12H00 (closing time will ONLY be determined by the municipal watch at the reception) on 25 August 2025 at which time bids will be opened in public. The name and address of the Bidder must be clearly written on the sealed envelope containing the Bid Document. Late submission, e-mail or fax bids will under no circumstances be considered.

Only bidders registered on Central Supply Database (CSD) will be considered and must provide proof of registration.
