Bids are hereby invited from suitable service providers for provision of security services, CCTV cameras installations, alarm monitoring systems, including repairs and maintenance of CCTV cameras and alarm monitoring systems at various Mandeni Municipality premises for 36 months

The physical address for collection of bids documents is Mandeni Municipality's Civic Centre, 2 Kingfisher Road, Mandeni Cashers Office upon payment of a non-refundable fee of **R600.00** (inclusive of VAT) (Cash or Debit Card or EFT: Ref no.: **Bid No 13/25/26 Bidder's Name**). Bid documents will be available from **Wednesday, 01st October 2025 to Tuesday, 14th October 2025** during working hours **Monday to Friday from 08h00 to 15h30**. Bidders who opt to pay via EFT may request the Municipal bank account details from the Manager SCM.

A compulsory clarification meeting with the representative of the Employer will take place at the Tugela Community Hall on Wednesday, 15 October 2025. The starting time is 11h00. Failure to attend compulsory clarification meeting with the Bid document will disqualify the tender. The doors to the venue will be closed at 11h00 and no bidder will be permitted to enter afterwards. Bidders that do not bring the document to the briefing will be disqualified.



The Mandeni Municipality subscribes to the preferential procurement policy framework Act, Act No. 5 of 2000 and its associated Regulations of 2022. Bids will be evaluated and adjudicated in terms of the Mandeni Municipality's SCM Policy in two stages. First stage of evaluation is functionality and second stage being price (form of offer). Bids shall be valid for a period of 120 days. All bidders must provide audited annual financial statements (AFS) for the past 3 years for companies required by law to be audited. For companies not required by law to be audited, AFS for the past three years or since the date of establishment if established during the past three years. The Mandeni Municipality does not bind itself to accepting the lowest bid, either wholly or in part or give any reason for such action. All prospective bidders will be screened in accordance with the National Treasury's Defaulters Data Base. Canvassing in any form of gift to Council is strictly prohibited and will lead to the disqualification of the bid.
