Bidders are hereby invited from suitable service providers for the establishment of a maximum panel of four and a minimum of three service providers to assist with tyre supply, fitment, repairs, and conduct, alignment on plant and equipment Light and Havey duty vehicles for a period of 3 years as and when required by Mandeni Local Municipality.

The physical address for collection of bid documents is Mandeni Municipality's Civic Centre, 2 Kingfisher Road, Mandeni Cashers Office upon payment of a non-refundable fee of R600.00 (inclusive of VAT) (Debit card, Cash or EFT: Ref no.: Bid No 18/24/25 Bidder's Name). Bid documents will be available from Wednesday, 22nd of October 2025 to Tuesday, 4th of November 2025 during working hours Monday to Friday from 08h00 to 15h30. Bid are to be completed in accordance with the conditions attached to the Bid document and must be sealed in an envelope and marked: "BID NO: 18/24/25 and Panel Of Service Providers For The Supply, Repair And Delivery Tyres For Light And Heavy Duty Vehicles For Three (3) Years As And When Required By Mandeni Local Municipality, and must be deposited in the tender box situated at the reception: Civic Centre, 2 Kingfisher Road, Mandeni no later than 12H00, on Friday, 21st of November 2025 at which time bids will be opened in public. Closing time will only be determined by the Municipal watch displayed on the Municipal wall at the reception. The name and address of the Bidder must be clearly written on the sealed envelope containing the Bid Document. Late submission, e-mail or fax bids will no circumstances be considered. Only bidders registered on Central Supply Database (CSD) will be considered.

The Mandeni Municipality subscribes to the preferential procurement policy framework Act, Act No. 5 of 2000 and its associated Regulations of 2022. Bids will be evaluated and adjudicated in terms of the Mandeni Municipality's SCM Policy in two stages. First stage of evaluation is functionality and second stage being price (form of offer). Bids shall be valid for a period of 120 days. The Mandeni Municipality does not bind itself to accepting the lowest bid, either wholly or in part or give any reason for such action. All prospective bidders will be screened in accordance with the National Treasury's Defaulters Data Base. Canvassing in any form of gift to Council is strictly prohibited and will lead to the disqualification of the bid.
