Suitably qualified bidders are hereby invited from suitable service providers for the Manufacture, Supply and Deliver 15 X 6 cubic meters steel refuse skips to Mandeni Municipality. Only Bidders who are registered with CIDB in a contractor grading of 2SL or higher will be eligible to Bid. In case of Partnership /Joint Venture a consolidated CIDB Registration Certificate meeting these requirements must be met. Bidders must have proof of CIDB Registration by the closing date failing which their bid will be disqualified.

Only bidders registered on Central Supply Database (CSD) will be considered.**
